**SUBJECT: ENVIRONMENTAL APPROVAL FOR COLLECTION, TRANSPORTATION, HANDLING, SEGREGATION & STORAGE OF HAZARDOUS WASTE/ SUBSTANCE AT M/S. EAGLE WASTE MANAGEMENT**


This is with reference to your letter No. Nil dated 05-08-2024 regarding collection, transportation, handling, segregation storage and safe disposal of Hazardous waste material from local industries in Sindh. In this regard, Sindh EPA has examined your case and accorded its approval with subject to strict compliance of following conditions:

- i. The proponent of **M/s. Eagle Waste Management** must comply with the Sindh Environmental Protection (SEP) Act-2014 and its Rules & Regulations made there under. No violation of any rules, regulation and provisions of SEP Act-2014 shall be made.
- ii. The proponent of **M/s. Eagle Waste Management** shall sole responsible for the compliance with Section 13, 14, 19, & 20 of the SEP Act-2014. The proponent of said waste management company shall also strictly comply with Hazardous Substances Rules 2014 in letter & spirit. Further, ensuring no violations of any regulations of the SEP Act-2014.
- iii. The proponent of **M/s. Eagle Waste Management** shall undertake all necessary measures to prevent pollution and take all requisite actions to control any type of environmental pollution generating from their activities. The proponent shall also liable to comply with the Sindh Environmental Quality Standards (SEQS). Furthermore, the proponent is obligated to maintain the facility in a condition of good housekeeping.
- iv. The proponent of **M/s. Eagle Waste Management** will be responsible for submitting Environmental Monitoring Reports (EMRs) on a regular basis, and the same shall be provided to the Sindh Environmental Protection Agency (SEPA).
- v. The proponent/ Owner of shall maintain good housekeeping standards for the proper storage and handling of hazardous substances/ material. These substances shall be stored in specific and authorized places within the facility premises of **M/s. Eagle Waste Management**. All safety measures shall be taken during the collection, segregation, handling, storage, transportation, and disposal of waste materials.
- vi. A complete code of health, safety and environment (HSE) shall be develop, which should include efficient parameters at work place of **M/s. Eagle Waste Management**.
- vii. The proponent of **M/s. Eagle Waste Management** is obligated to maintain a comprehensive qualitative and quantitative record of hazardous waste (both non-hazardous and hazardous), including its nature, quantity, and method of disposal. This approval is only pertains to the handling of hazardous waste material/ substances, and the proponent shall not expand operations beyond the project's scope.

- viii. The proponent of **M/s. Eagle Waste Management** shall provide, as per the NFPA (National Fire Protection Authority) codes, the fire and smoke detection and protection devices such as smoke detectors, alarms, extinguishers, sprinklers, fire hoses and hydrant as deemed appropriate to respond to the fire hazards associated with the your facility.
- ix. The waste material shall not be disposed of at unauthorized locations, and it shall be disposed of through SEPA-approved facilities, such as an Incinerator Plant, ensuring its scientific disposal without causing any damage to the environment.
- x. The proponent of **M/s. Eagle Waste Management** shall also submit a copy of the agreement in the case of a third party who possesses disposal facilities, such as an incineration facility.
- xi. The proponent shall implement waste management plan for handling of hazardous waste material/ substances, which shall be subject to examination by this Agency at any time.
- xii. In case of any emergency, loss, damage the proponent of the waste management company is totally bound to compensate the affected and make it good as original.
- xiii. The proponent of **M/s. Eagle Waste Management** shall submit a separate Waste Management Plan for approval by this Agency, specifically addressing the handling of non-hazardous waste materials. This submission must also include an Environmental Screening (through Checklist) report under Schedule (a)(iii) of the Sindh Environmental Protection Agency (Environmental Assessment) Regulations 2021.
- xiv. This approval does not apply to the import of any banned items from the Ministry of Commerce, Government of Pakistan, or any other items restricted under any Multilateral Environmental Agreement, including the Basel Convention.
- xv. All mitigation measures provided in the HSMP report must be strictly adhered to in order to minimize effects on the surrounding area. Implementation must commence immediately, ensuring compliance with the provisions of the SEP Act-2014 and its Rules & Regulations made there under.
- xvi. The proponent of **M/s. Eagle Waste Management** shall be solely responsible for the implementation of the Hazardous Substances Management Plan/ report. If any violation found then this approval shall stand cancelled without any prior notice from this Agency.
- xvii. Sindh EPA shall visit the facility of **M/s. Eagle Waste Management** for checking/ examine the conditions of the approval of the HSMP and compliance of SEP Act-2014 and its Rules & Regulations made there under on regular basis. No hurdle shall be created for this Agency Staff during entry & inspection of the facility. Sindh EPA may propose further mitigation measures in the light of recommendation of visiting team at any stage and stipulate additional conditions for compliance with the SEP Act-2014 and its Rules & Regulations made there under.
- xviii. Sindh EPA reserves the right to issue instructions for an independent environmental audit at any stage of the facility of **M/s. Eagle Waste Management**.
- xix. The proponent of **M/s. Eagle Waste Management** shall be solely responsible for the information provided through the HSMP report. In case of any misrepresentation or concealment of facts, this approval shall be cancelled without prior notice.
- xx. That this approval is provisional and shall be treated canceled without any intimation/ notice if any of the above-mentioned conditions are violated or not complied.
- xxi. This approval is not valid for any court matter/ dispute.
- xxii. The competent authority may revise or amend/ withdraw this approval, if deemed necessary in the Public/ National interest.
- xxiii. That this approval is valid for the period of **ONE (01) year** and shall be expired on **06-08-2025**.
